- The offer of receiving \$200 CAD/USD upfront commission at time of booking is applicable for industry bookings paying in CAD or USD excluding agencies that are on statement. - This offer applies to indirect bookings made between August 1st, 2020 6:00am PST and August 31st, 2020 11:59pm PST and is for trips departing between January 1st, 2021 and December 31st, 2022.
- The offer is valid on Intrepid Travel small group adventure trips and Peregrine Adventures small group adventure trips excluding Tailor-Made trips, Australia trips and 18-29s trips.
- The offer is only applicable to bookings with a minimum booking value of \$2,000 CAD/USD.
- A deposit of \$400 USD/CAD is required at the time of booking. A deposit of \$600 USD/CAD is required at the time of booking on Adventure Cruising voyages and Peregrine Adventures.
